REPORT READING

Dr. Priya Subramaniam, Member Secretary welcomed all the members of Governing Council. The meeting was called to order by the Member Secretary Dr. Priya Subramaniam, Principal, The Oxford Dental College, who introduced all the members who were present. Member Secretary gave a brief introduction about the institution, regarding year of establishment and recognition of MDS & BDS Degree.

DISCUSSION ON AGENDA

1. Admission of Students to BDS & MDS Courses in the Academic year 2016-17.

Member Secretary read out the status of admissions for BDS & MDS. Total seats sanctioned for BDS is 100 seats, out of which 18 students were admitted through NEET, 20 students under CET Quota & 15 students were admitted under NRI & Foreign Nationals Quota.

Total seats sanctioned for MDS is 66 seats, 60 students were admitted to various specialities

through KRLM & PUCET. Students admitted through KRLM is 46 and through PUCET is 14 seats. Seats were surrendered to the Government in 3 departments Oral Medicine - 1, Public Health Dentistry - 3 & Oral Pathology - 2 seats (Copies enclosed)

2. Conduct of CDE Programs & Camps during the academic year 2016-17.

16 CDE programs were conducted for the year 2016-17. Departments of Public Health Dentistry and Pedodontics conducted 52 camps & outreach programs. The pedodontics also conducted School Dental Health Program in various schools in Bangalore. (Copies enclosed)

3. Approval of appointments of faculty & Promotions

Fresh appointments of faculty were made in various departments. Promotion of existing faculty to higher designations was also done in certain departments as per the requirement. (List is enclosed)

4. Conduct of Parent Teacher Meeting.

Every year Parent Teacher Meeting is conducted. This year it was held on 21.02.2017 Ist & IInd Year BDS & 22.02.2017 for IIIrd & IVth year BDS. Highlights of the meeting is enclosed in the report.
