PREAMBLE:

The Registrar, Bangalore University, Bangalore vide his letter dated 10.4.1992 read above, has recommended to affiliation for starting a Dental College to Children's Education Society, Bangalore in the name of The Oxford Dental College, J.P.Nagar, Bangalore under section 53(5) of the Karnataka State Universities Act, 1976 for the year 1992-93 with an intake of 40 seats.


GOVERNMENT ORDER NO.HFW 97 MME 92, BANGALORE, DATED 11TH MAY 1992

After consideration of the proposal of the Registrar, Bangalore University, Bangalore, Government are pleased to accord sanction to start new Dental College to Children's Education Society, Bangalore in the name of The Oxford Dental College, J.P.Nagar, Bangalore with an intake of 40 seats during the academic year 1992-93, subject fulfilling the following conditions:

- 1) the institution should take immediate action to obtain the approval from the Dental Council of India;
- 2) that the institution ~~now~~ should not seek any assistance from the State Government for running the Dental College;
- 3) they must have their own building within two years with adequate facilities, laboratories, libraries, class rooms, equipments and adequate teachers in various subject as prescribed by the Dental Council of India;
- 4) they must get the clinical facilities at the earliest and intimate to Government;

- 5) they should prepare to abide and fulfill whatever other conditions laid down by the University and the Government as and when it is found necessary; and
 - 6) Dental Council of India norms should be strictly followed.

PREAMBLE:- In the letter read at(1) above, the Registrar, Bangalore University, Bangalore while forwarding the documents as required under Section 53 of the Karnataka State Universities (Amendment) Act, 1986 has stated that the Local Inquiry Committee of Bangalore University visited the Oxford Dental College, Bangalore on 19.1.1995 and recommended to increase the intake of B.D.S Seats from 40 to 100 from the academic year 1995-96. He has further stated that the recommendation of Local Inquiry Committee has been approved by the Academic Council and the Syndicate of the Bangalore University.

In the letter read at (2) above, the Director of Medical Education, Bangalore based on the Inspection Conducted by the Principal, Government Dental College, Bangalore has also recommended for increase of intake i.e., 1st year B.D.S. Seats from 40 to 100 in respect of Oxford Dental College, Bangalore from the academic year 1995-96.

In the Government Order read at (3) above, the Government of Karnataka were pleased to grant Linguistic Minority Status to the Oxford Dental College, Bangalore run by the Children's Education Society, J.P.Nagar, Bangalore from the academic year 1995-96 subject to the conditions laid down in the said Government Order.

Taking all the aspects into consideration, the Government has examined and considered the proposal of the University of Bangalore as well as the Director of Medical Education to increase the intake of the Oxford Dental College, Bangalore and decided to grant permission accordingly.


